- 5. Rental Rate and Fees: The rental fee is \$2000.00 + 8% PST (as required by law) per week
 - I. A deposit of \$1080.00 is due to secure your rental at the time of booking.
 - II. A second installment of \$1080.00 is due 4 weeks prior to the arrival date.
 - III. A damage / cleaning deposit of \$900.00 is due 1 week before your arrival (see schedule B).

The deposit is for security and shall be fully refunded within 7 days of the checkout date via e-transfer provided no deductions are made due to:

- i. Damage to the property or furnishings
- ii. Dirt or other mess requiring excessive cleaning; or
- iii. Any other cost incurred by the Homeowner due to the RENTER's stay.
- 6. <u>Insurance</u>: It is encouraged that the RENTER and the rental party purchase travel insurance.
- 7. <u>Liability</u>: The Homeowner's shall not be responsible for any accident or injuries occurring to the RENTER, the rental party or guests of the rental party, on the property or premises. The Homeowner's are not responsible for any injuries sustained on or in the property. The RENTER hereby agrees to reimburse the Homeowner for any penalty that may be imposed on the Homeowner's by any court due to any violation upon the premises through fault of the RENTER therein, the rental party, his/her family members or guests.
- 8. The RENTER agrees to pay the owner for any damages to the premises and property, including but not limited to: furnishings and household items, which occur as a result of the RENTER's occupancy.

Schedule A – Property & House Rules

- 3. People other than the RENTER and those in the rental party set forth above may not stay overnight on the property. Any other person on the property is the sole responsibility of the RENTER. The RENTER & the Rental Party are not allowed to exceed the occupancy limit as set above.
- 4. Guests should not create excessive noise at a level that disturbs neighbors.
- 5. The Homeowner is not responsible for any accidents, injuries or illness that occurs while on the premises or its facilities.
- 6. The Homeowner is not responsible for the loss of personal belongings or valuables of the RENTER and the Rental Party.
- 7. By accepting this reservation, it is agreed that all guests are expressly assuming the risk of any harm arising from their use of the premises or others whom they invite to use the premises.
- 8. Keep property and all furnishings in good order.
- 9. Use appliances only for their intended uses.
- 10. The house is on a well and septic system. Please conserve water and make sure all taps are turned off after use. The septic system is a delicate system and will clog up if improper material is flushed. Do not flush anything other than toilet paper. No feminine products should be flushed at any time. Do not put any fat / oil down the drains.

When you leave, you hereby agree to do the following:

Please respectfully take care of items listed or you will be charged a fee from your damage deposit as described in schedule B.

- Report any damage and/or equipment not working properly
- Shut off all electronic devices & equipment
- Turn heating system down to 10 upon leaving.
- Remove all used bed sheets, towels & cloths & place in laundry bins (please do not remove Duvets, duvet covers, quilts or mattress/ pillow covers)
- Please wash and return all clean dishes to cupboards & drawers.
- Take ALL garbage & recycling to garbage / recycling center, which is open from 9 am to 1:00 pm on Friday. Make sure you check all garbage bins bathroom included.
- DO NOT leave garbage outside on decks or driveway as it will attract animals (i.e. Deer or small rodents) that could cause damage that you will be responsible for
- Use BBQ brush if necessary to remove debris off of BBQ grills
- Ensure BBQ gas is OFF
- Ensure fire pit is OFF
- Ensure fridge & freezer are empty (other than empty ice cube trays)
- Shut off ALL light switches
- Ensure windows are locked
- Close & lock all French doors

Schedule B – Extra Cleaning & Other Fees

The RENTER and the Rental Party agree to the following charges if applicable:

- ➤ Dishes not washed \$50.00
- ➤ Garbage / Recycling left \$100.00
- > Fridge not clean \$50.00
- ➤ Food & other items left \$50.00
- ➤ Late checkout you are required to have all personal items taken and leave the premises by 11:00 am sharp. If you are still there after 11:00 you will be charged a \$250.00 late checkout fee.
- > Smoking entire damage deposit + monies paid and will be asked to leave
- > Pets entire damage deposit + monies paid and will be asked to leave
